Step 5: Enroll your Organization & Select Your PCA & HCCN

Select "Enroll" on the NACHC Value Transformation Framework page to open a pop-up where you can select your organization.

1) Find Your Organization

In the field labeled 'Organization Name', your organization name will automatically populate as you start to type. If you cannot find your organization, select "Can't find your organization". A prompt will open, allowing you to add your organization name. Once added, you will need to wait for RegLantern Support to confirm that you are now enrolled with your organization.

Add your PCA and HCCN

Adding your PCA and HCCN allows them to view your health center's organizational assessment results to help inform and drive its transformation activities and health center support. PCAs and HCCNs can also send reminders to member health centers when it is time to complete a new VTF assessment.

Step 5: Enroll your Organization & Select Your PCA & HCCN

Select "Enroll" on the NACHC Value Transformation Framework page to open a pop-up where you can select your organization.

Add your PCA and HCCN

2) Find Your PCA

In the field labeled 'Find Your PCA', begin typing the name of the Primary Care Association (PCA) of which your health center is a member. The name will automatically populate as you start to type. The PCA selected will be able to see your health center's assessment scores. If you prefer not to enter your PCA, you may leave this field blank.



3) Find Your HCCN

In the field labeled 'Find Your HCCN', begin typing the name of the Health Center Controlled Network (HCCN) of which your health center is a member. The name will automatically populate as you start to type. The HCCN selected will be able to see your health center's assessment scores. If you are not a member of an HCCN, or if you prefer not to enter your HCCN, you may leave this field blank.

If you are already enrolled but did not add a PCA or HCCN, you may add them at any time by clicking on the gear icon at the top of the page, then selecting edit profile.

Step 6: Complete your assessment!



1) Click on 'My Organizational Assessment'

2) Take the Assessment

Click each of the 15 change areas and choose the level that best reflects your health center's current processes and capabilities. Only mark a number if your organization has fully met all listed criteria for that level.



For example, if your health center has met all the criteria in Levels 1, 2, and 3 and some criteria in Levels 4 and 5, select Level 3. Once a score is marked, click the next change area to proceed.

3) Submit the Assessment



After scoring all 15 items, click **"Submit to NACHC"** at the bottom of the page. Your scores will then be available to view by your health center colleagues, and your PCA/HCCN if you selected them in Step 5.

Over the course of your participation in Elevate, you can go back to your scores and adjust as necessary. Just make sure you click the "Submit to NACHC" button to save any changes!
